This continues the programs already implemented with CARES and ESSERII funding for summer 2020, 2021 and school year programs 2021. Students will be admitted using benchmark data, grades, teacher and parent recommendation. All students including those with disabilities, English learners, students with 504 and other vulnerable groups for small group instruction with certified staff.

Closter Public Schools will use ARP ESSER Funds to install new heating, ventilation, and air conditioning (HVAC) system in the STEM Lab at Hillside Elementary School and B209 at Tenakill Middle School. We will also use a portion of the grant to replace windows at Tenakill Middle School so it can easily be opened for natural ventilation and improve indoor air quality.
